Vendor Agreement

Deadline for Application & Agreement: October 3

Food & Drink Vendors are open 9 am-2 pm

I understand and agree to the following:

1. All vendors must be self-contained. (You must provide your own generator if electricity is needed.)
2. The City and Palm Desert Area Chamber do not provide water, ice or electricity. Food and Drink Vendors are expected to supply their own tables, chairs, canopy, etc. for booth.
3. You will be assigned a specific location on El Paseo. You agree to the location identified on the City approved map for the event.
4. Vendors must be set up before 8:00 am on Sunday, October 29, 2017. Health Department inspection is at 8:30 am. All vehicles must be parked in assigned areas.
5. After event, all vendors must clean up their space completely, taking all unused product, boxes, supplies, etc. with you. No trash or debris of any kind may be left.
6. **ALL VENDORS MUST OBTAIN A CITY OF PALM DESERT SPECIAL EVENT PERMIT** to participate.
7. Vendors shall provide a **\$1,000,000 general liability insurance policy** covering the City of Palm Desert, the Palm Desert Area Chamber of Commerce and Golf Cart Parade. Your certificate of insurance must accompany this agreement.
8. **INSURANCE WAIVER:** Vendors agree to hold harmless the City of Palm Desert, Palm Desert Area Chamber of Commerce and the Golf Cart Parade Committee, its officers, staff, and volunteers should an incident occur.
9. Vendors will have Health Permits and follow all health codes.

In order to ensure proper coordination of types of food and supply of each type, please do not make changes in your product or food items without approval of the Vendor Committee Chairperson or Co Chair.

Time for Sales: Vendor booths will be open for business from 9:00 am until 2:00 pm.

Who can be a Vendor?

Anyone providing food or non-alcoholic beverage products may apply. (Sale of non-food or beverage items is not permitted.)

What are the Specific Requirements for Vendors with food/drinks?

1. Food Vendors will need a Health Department permit. Contact the Riverside County Environmental Health Department at (760) 863-8287.
2. All vendors will need a special event one-day permit from the City of Palm Desert (available at Palm Desert City Hall, Community Services Building, Business License Department). This is for all vendors. (The fee for non-profit vendors is waived, but you must still apply for the permit.) Contact Business License Department at (760) 346-0611, ext 443.
3. Food Vendors need to be set up and ready the day of the parade for a Health Department inspection beginning at 8:30 am. Open for business at 9:00 am. The Vendor Chairman will begin assigning spaces as early as 7:00 am. No vendor should arrive after 8:30 am, if so, your space may be given up.
